# **COMPETITION TERMS AND CONDITIONS**

### 1. IMPORTANT NOTICE

- 1.1 These terms and conditions and rules of the Competition contain certain terms and conditions which appear in similar text style to this clause and which:
  - 1.1.1 limit or may limit the risk or liability of the Promoter and / or a third party; and/or
  - 1.1.2 create or may create risk or liability for the Participant; and/or
  - 1.1.3 indemnify or may compel the Participant to indemnify the Promoter and / or a third party; and/or
  - 1.1.4 serves as an acknowledgement, by the Participant that he/she has read and understood the Terms and Conditions of the Competition.
- 1.2 The Participant's attention is drawn to these Terms and Conditions, which are legally binding and should accordingly be carefully considered and noted by the Participant.
- 1.3 Nothing in these Terms and Conditions is intended to or shall be misconstrued as unlawfully restricting and / or limiting any rights and / or obligations, as the case may be, created for either the Participant or the Promoter in terms of the Consumer Protection Act, 68 of 2008 ("the CPA").

- 1.4 The Participant acknowledges that by submitting his / her / their entry to the Competition he / she / they has/have been given an appropriate opportunity to first read these terms and conditions before entering and that he / she / they understand/s and agrees to be bound by these terms and conditions.
- 1.5 Should any provision of the Terms and Conditions require interpretation, such provision will be interpreted by the Promoter in its sole and absolute discretion.
- 1.6 All Participants to this Competition participate entirely at their own risk. By reading and accepting these Terms and Conditions, the Participant consents to these risks and hereby indemnifies and holds harmless the Promoter and all its subsidiaries and associated entities; their directors, employees and agents from any and all liability pertaining to any damage, cost, injuries and losses of whatever nature sustained as a result of their participation in the Competition and, where applicable, related events and activities, or resulting from the acceptance of and / or use of the prize/s on offer, including but not limited to loss/damage arising out of/pursuant to personal injury, death, property damage and claims based on publicity rights, defamation and/or privacy rights.

#### 6. SELECTION OF COMPETITION WINNER/S

6.1 Winners will be randomly selected by a panel of judges from all entries which answered the Competition question correctly. The decision by the judging panel is final and no further deliberation will be entered into.

- 6.5.4 A director, member, partner, employee, agent of or consultant to, spouse, life partner, parent, child, brother, sister, business partner or associate of any person contemplated in clause 3.5.3 above; and
- 6.5.5 Any supplier of the prize under the Competition, may not participate in the Competition and will be ineligible to receive all/any prize/s on offer.
